Overall condition of the vehicle is in "GOOD" condition. No commitments were made. Estimate completed using prevailing labor rates in that area. The estimate amount has exceeded the repairable value with inner structure & mechanical "OPEN". Therefore we suggest this vehicle be deemed a total loss. The vehicle remains at C&B Towing collecting \$40.00 /day storage since 06-02-2013 with a Tow: \$206.25 & Lien: \$35.00 in advanced charges. Did not move insured vehicle. Note: Register owner of vehicle who is insured some in out of the country, per tow yard vehicle need to be release by him to move
