VEHICLE HAS MODERATE RIGHT FRONT END DAMAGE. DIRECT IMPACT TO FRONT BUMPER, RT HEADLAMP, RT FENDER, RT FRONT DOOR, RT DOOR MIRROR AND RT FRONT WHEEL COVER. DAMAGE ALSO VISIBLE TO RT FRONT FRAME RAIL, RT UPPER TIE BAR, RT FRONT APRON AND FRONT FRAME STRUCTURE. DAMAGE EXTENDS FROM ABOUT 6IN. TO 3FT.6IN. FROM GROUND LEVEL.
